ACKNOWLEDGMENT OF RISKS

- Risks associated with crowded public spaces

I voluntarily choose to participate in the Event and knowingly assume all risks associated with my participation, whether known or unknown.

RELEASE OF LIABILITY

In consideration of being permitted to participate in the Event, I, on behalf of myself, my heirs, executors, administrators, successors, assigns, and personal representatives, hereby release, waive, discharge, and covenant not to sue:

- Event sponsors
- Participating retailers and tenants
- Event organizers
- Volunteers
- Employees, officers, directors, agents, contractors, affiliates, and representatives of any of the foregoing

(collectively referred to as the "Released Parties")

from any and all claims, demands, causes of action, liabilities, damages, losses, costs, expenses, or attorney's fees arising from or related to my participation in the Event, including those resulting from personal injury, illness, death, property damage, or other loss, except where prohibited by applicable law.

INDEMNIFICATION

I agree to indemnify, defend, and hold harmless the Released Parties from and against any claims, liabilities, damages, losses, expenses, or costs arising out of or related to my participation in the Event, my actions during the Event, or any breach of this agreement.

MEDICAL AUTHORIZATION

I certify that I am physically capable of participating in this Event and have no medical condition that would make participation unsafe.

In the event of an emergency, I authorize Event personnel to secure medical treatment on my behalf if I am unable to do so. I understand that I am solely responsible for any medical expenses incurred as a result of my participation.

RULES AND CONDUCT

I agree to follow all Event rules, instructions, and directions provided by Event staff. I understand that unsafe, disruptive, unsportsmanlike, or inappropriate behavior may result in immediate disqualification and removal from the Event without refund or compensation.

I understand that Event organizers reserve the right to modify, postpone, suspend, or cancel the Event due to weather, safety concerns, operational needs, or circumstances beyond their control.

PHOTO, VIDEO, AND MEDIA RELEASE

I grant Golden Triangle Mall and its representatives the irrevocable right to photograph, videotape, record, and otherwise capture my likeness, voice, image, and participation during the Event.

I authorize Golden Triangle Mall to use, publish, reproduce, distribute, display, and create derivative works from such photographs, recordings, and media in any format or medium, now known or later developed, for advertising, marketing, promotional, public relations, social media, website, and other lawful business purposes without compensation or further approval.

I waive any right to inspect or approve the final use of such materials.

PRIZE ACKNOWLEDGMENT

I understand that any prizes awarded are subject to Event rules and eligibility requirements. Event organizers reserve the right to verify results and determine final winners.

I acknowledge that prize values may be reportable for tax purposes and that I am responsible for any applicable taxes associated with prizes received.

SEVERABILITY

If any provision of this agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

GOVERNING LAW

This agreement shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflict of law principles.
